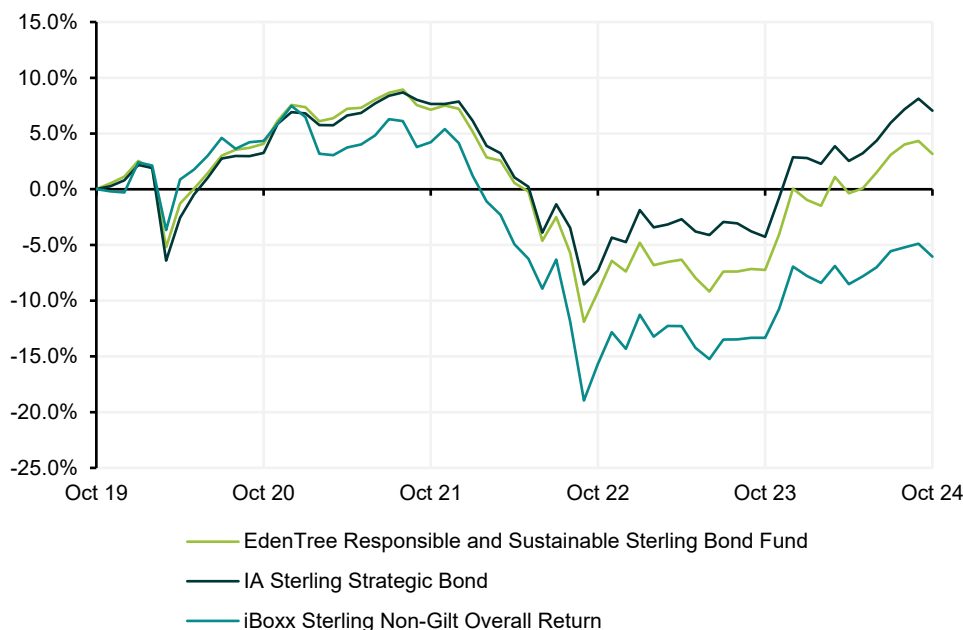

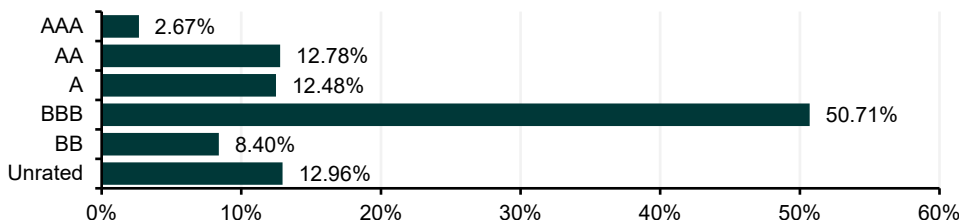

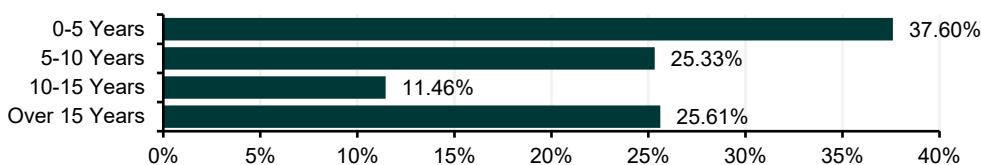

Bond Maturity



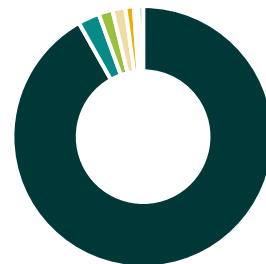
