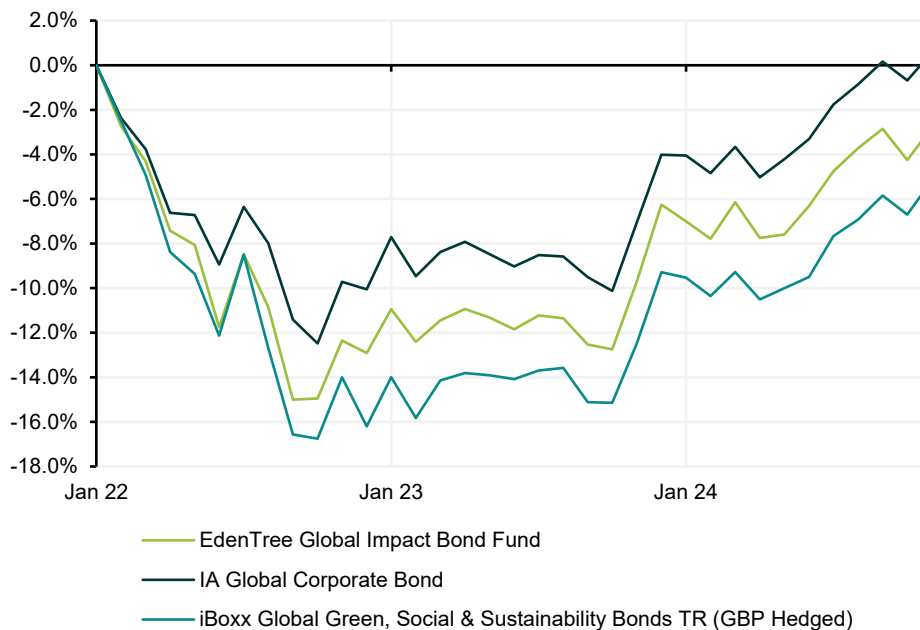

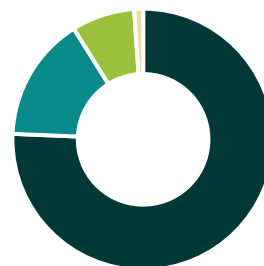

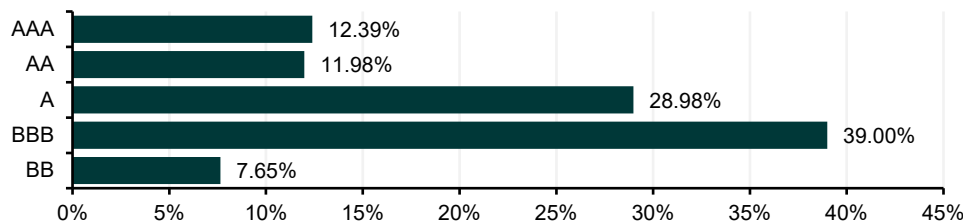


Currency Allocation

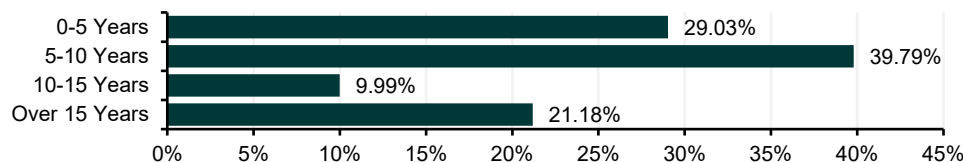
