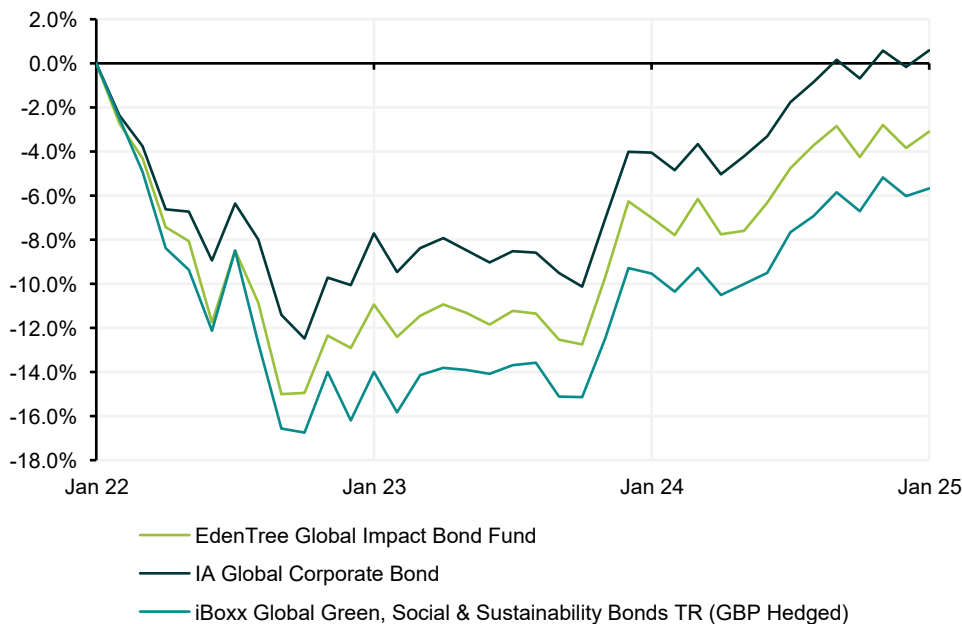

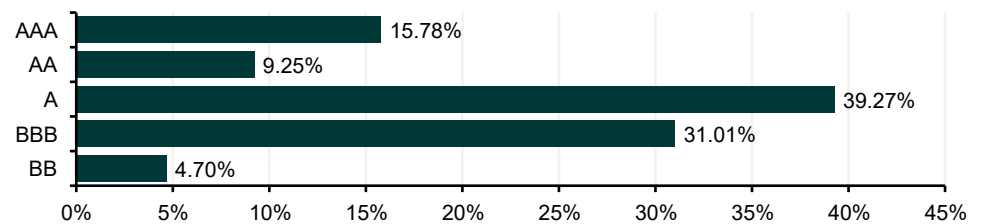


Currency Allocation

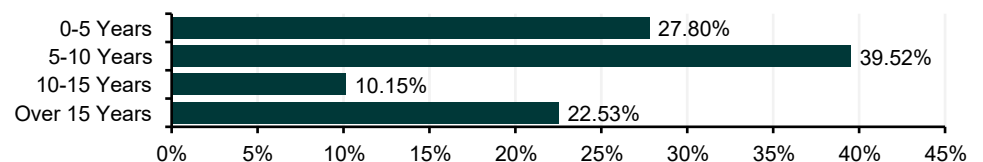
