This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

This is a sub-fund of EdenTree Investment Funds – Series 2, an open ended investment company managed by EdenTree Investment Management as the Authorised Corporate Director.

OBJECTIVES AND INVESTMENT POLICY

To provide long term capital growth and income over five years or more.

The Fund will aim to achieve its investment objective by investing in a mixed investment portfolio that has a bias towards equities provided this remains consistent with achieving the Fund's objective. It aims to achieve its objectives with a higher level of risk relative to the other funds within the EdenTree Multi-Asset fund range. The Fund will also invest in assets in line with its Sustainability Approach, as outlined below.

The Fund will seek to invest indirectly in assets through other funds as well as directly in a mixture of different asset classes (including, but not limited to, UK and overseas equities, bonds, cash, listed infrastructure and property REITs). It may also gain exposure to commodities through other collective investment schemes, invest in exchange traded commodities and derivatives.

The Fund is managed to a "growth" risk and return profile, which it seeks to achieve by investing at least 70% of the assets in sustainable investments, with the ability to invest up to 30% in other assets that do not conflict with the Fund's preference for sustainable assets.

In order to be considered sustainable, an underlying Fund will need to satisfy one of the following conditions:

- 1. The Fund has a label under the FCA's Sustainability Disclosure Requirements ("SDR").
- Funds within the EdenTree range of Funds which are subject to both
 - a. the Manager's proprietary baseline standards
 - b. the Manager's positive business assessment against the six key areas of:
 - i. Environment and Climate Change
 - ii. Employment and Labour
 - iii. Human Rights
 - iv. Business Ethics
 - v. Community
 - vi. Corporate Governance
- 3. Funds within the EdenTree range of Funds which are subject to both
 - a. The Manager's proprietary baseline standards.
 - b. Investment themes, as defined by the Manager, which require at least 70% of the Fund to be invested in companies which aim to provide solutions to social and/ or environmental challenges.
- 4. The Fund is classified as a sustainable investment under a recognised overseas sustainability regulatory framework.



Any investment held by the Fund directly will need to meet EdenTree's sustainability standard, which consists of the baseline standards and positive business assessments as summarised above.

You may buy and sell shares on any day on which the London Stock Exchange is open for business. Income from investments in the Fund will be added to the value of your shares. The Fund may not be appropriate if you plan to withdraw your money within 5 years.

RISK AND REWARD PROFILE



The risk category above is not a measure of capital loss or gains, but of how significant the rises and falls in the Share Class price.

- For example a Share Class whose price has experienced significant rises and falls will be in a higher risk category whereas a Share Class whose price has experienced less significant rises and falls will be in a lower risk category.
- As the Share Class risk category has been calculated using simulated historical data, it may not be a reliable indication of the Share Class future risk profile.
- Please note that the Share Class risk category may change in the future and is not guaranteed. The lowest risk category does not mean a risk-free investment.
- The Share Class is in risk category 5 as its price has experienced significant rises and falls historically based on simulated data. The Fund was launched in July 2021 and therefore the risk category is based on simulated data to 30 June 2021 with actual fund data thereafter.

What risks are associated with this fund?

CHARGES FOR THIS FUND

The ongoing charges figure is based on annualised expenses for the year ending 31 December 2024. This figure may vary from year to year and excludes portfolio transaction costs.


The ongoing charges figure (OCF) includes all appropriate costs that may be deducted from the Fund's assets, in line with current regulatory and industry guidance. The OCF includes a synthetic element relating to the costs incurred by underlying collective investment undertakings, where permitted by the Prospectus. The synthetic element of the total OCF was 0.13%.

The direct ongoing charges is currently capped at 1.40%. The direct ongoing charges charged to the Fund will be the lower of the cap and the actual direct ongoing charges figure. The actual direct ongoing charges figure is estimated to be 5.31%. The total ongoing charges, including the synthetic element is 5.44%.

If you switch Funds within the EdenTree Investment Management range you will be charged a maximum 1% entry charge on your new Fund. The switching charge is currently set to zero
